DRAFT PROPOSAL FOR IT/ITES SEZ

A startup township can be well established in 65 Acres of rectangular roadside contiguous plot in the form of IT/ITES SEZ with in 25 Kms from Renigunta International Airport in Chitoor District Andhrapradesh(13.633797 N, 79.777329 E) with in 100 Kms from Chennai city ,35 Kms from Sri City MPSEZ,50 Kms from Tirupathi and 15 Kms from Srikalahati .

Located on the south of Anjuru Tank 1 Km on the west of Kalingi River and 2.5 Kms downstream on the North of existing Kalingi reservoir which is scheduled to be expanded to 3 TMC feet at a total cost of 439 crores with financial assistance from JICA, Japan International Cooperation Agency.

On the east of this 65 Acres Private Patta land which we have acquired from private people, there is another 65 Acres of Government Land in survey numbers 124,195 of Suramala ,Chellamambapuram villages situated in Brahmanapalli and Guntipedu Revenue groups respectively.



This Government land is not suitable for cultivation but it will make our proposed SEZ plot a contiguous 130 Acres single parcel of rectangular land which can take care of a comprehensive IT/ITES startup village with international standards.

The single road from Renigunta International Airport to the proposed 125 Acres site via Kailashgiri reservoir and Telugu Ganga Project(TGP) Pumping station and Anjuru TGP canal Aqueduct should have to be converted into a double road as this entire area has been proposed o be included in the megacity boundaries of Tirupathi.

The Kaalingi Reservoir and Ubbalamadugu Reservoir are proposed to be expanded to store not less than 8 TMC of water to stabilize drinking water supply for future drinking water requirement of Tirupathi mega city which is being developed into an IT hub and a city of lakes.


Why Suramala is favoured destination for IT/ITES SEZ?

- 1. Tirupathi is attracting IT / ITES companies as it is growing and expanding as mega smart city.
- 2. It will take another 5 years for Chennai to have storm drain mechanism in place and due to climatic changes Chennai is expected to have severe rain which will inundate the city especially IT industry in south Chennai and East Chennai making it compulsory for them to think about disaster mitigation for IT industry for which Tirupati is more ideally suited as it is located within golden triangle of Tirupati-Chennai-Bangalore according to NASSCOM estimates. The proposed site is within 25 Kms from Renigunta International Airport with abundant drinking water sources as it is 1 Kms from Kaalingi river, 2.5 Kms from downstream of Kaalingi reservoir which has independent catchment area not depending on Krishna waters which are subject to filling of Alamatti and Narayanpur dams.
- 3. It is 6 Kms from pichatur- Tirutani double road from TGP station, 8 kms from Kotha Kandriga, 25 Kms from Renigunta International Airport,1 Km from Kalingi river, 2.5 Kms from Kalingi reservoir, 119 kms from Chennai.
- 4. Tirupati had attracted all the projects listed below in the proposal as it is new growth center for all economic activities with predominately manufacturing and services industries.
